Rules and Regulation of Shikshan Prasarak Mandal, Chikhli.

**PREMBLE :-** Whereas at a meeting held at Chikhli on 15th May 1956 it was resolved to start a Society at Chikhli under the name of and style of "THE SHIKSHAN PRASARAK MANDAL, CHIKHLI" and to frame the rules of the constitution of the said Society, the same are framed as under :-

**PART :- I**

**(1) NAME OF SOCIETY :-** The Shikshan Prasarak Mandal, Chikhli, (Dist. Buldana) M.S.

**(2) Aims and objects**

- (A) :- To promote the cause of education.
- (B) :- To serve the education needs of the public.
- (C) :- For the attainment of the above objects establish schools and to take existing institutions under its control.
- (D) :- To Institute Scholarships and award prizes etc, to students in order to encourage the cause of education.
- (E) :- To carry on necessary experiments in order to effect improvements in field of education.
- (F) :- To raise the necessary funds for the attainment of the above aims and objects.

**(3) DEFINITIONS..... :-** The member of the institutions shall be of three kinds.

**(A) Funder Members**

- :- Are all persons who have actually funded the Society and who have helped to establish the same by giving monetary as well as other sort of help and whose names appear in the schedule No.1. annexed patrons.

**(B) Patrons**

- :- Persons contributing Rs.1000/- or more in lumpsum to the fund of the society shall be called patrons.

**(C) Ordinary Members**

- :- Persons contributing Rs. 1000/- per year shall be called ordinary members.

**(4) MEMBERSHIP**

- :- The membership of the society shall be open to all the persons mentioned in rule No.3 clause 2 & c above and who agree to abide by the rules of the constitutions of the society. For admission to membership persons must apply to the Governing Body.

- (11) EXTRA ORDINARY MEETINGS :- The president, shall have the power to call an extra ordinary meeting of the Sanchalak Mandal, if necessary. The president shall have to call a special meeting of 2/3rd members if the Sanchalak Mandal shall make a demand in writing for the same to the President to consider some specific subjects :-
- (12) ELECTION OF OFFICE BEARERS :- Members of the Sanchalak Mandal will elect President and Vice-President of Sanchalak Mandal.

P A R T - III

- (13) GOVERNING BODY :-  
Constitution of Governing Body. The governing Body shall consist of :-

Thus the Governing Body shall consist of all members. The members of the Governing Body shall elect a President, and two Secretaries, for themselves.

The President and the secretary of the Governing Body shall act as the president and Secretary of Shikshan Prasarak Mandal as well as Sanchalak Mandal.

- (14) The Governing Body shall be in Office for a period of five years only. They shall hold Office till the new Governing Body is elected under the provisions of the rules and assumes office.

- (15) Function of the Governing Body :-  
The Governing Body shall have the following powers.

- (a) To accept donations and acquire loans for the Society.  
(b) To sanction proposals for expenditure on buildings and other equipments.  
(c) To make and carry out, vary or cancel contracts on behalf of the Society and to appoint teachers and servants.  
(d) To sanction promotions, transfers and removals of the teachers and the servants of the Society.  
(e) To suggest amendments to the Rules and Regulations of the Society.  
(f) To dispose off the applications for the memberships of the Society.  
(g) To prepare and submit Annual Reports for the Annual General meeting.  
(h) To undertake acts which may be conclusive at the interest of the Society or which may be necessary and desirable in further of the aims and objects of the Society.

- (16) Meeting of the Governing Body :- The Governing Body shall meet at least once in every three months. The decision of meeting shall be taken by majority.

- (17) The president, shall preside at all meetings of the Governing Body. In his absence the Vice-President shall preside over the meeting. In the absence of both, the members present shall elect any one as President, from among themselves.
- (18) At least six members of the Governing Body will form quorum. If there be no quorum the meeting shall be adjourned. The adjourned meeting be held at the same hour, the next day at the same place. The adjourned meeting shall not require any notice.
- (19) NOTICE OF MEETING :- Notice of any meeting of the Governing Body be served at least two days before the date of meeting. The notice shall be treated as served if it is posted under certificate of posting and postal cert. to that effect is obtained.
- (20) Election of the Office bearers :- Immediately after constitution of the Governing Body, it shall proceed to elect from amongst its members the following office bearers of the Society.
- (21) Suits and Execution of Documents :- The Society shall be used or be used in the name of the president and all the documents of title or financial contracts, in connection with the same shall be executed by the Secretary on behalf of the Society.

P A R T - IV

- (22) FINANCE :- The funds of the Society shall be deposited with the postal Savings Bank. The accounts of the Saving Bank shall be in the name of the President or Secretary.  
The President and Secretary, shall have the power to make and expenditure to the extent of Rs. 1000/- without the consent of the Governing Body. In addition to this the Secretary shall keep Rs. 300/- with him for current expenditure.
- (23) PERMANENT ASSETS :- Permanent assets include all such property not belong to any individual but shall be owned by the Society.

P A R T - V

- Amendments to the rules and regulations of the Society :-  
(24) The annual General Meeting shall have powers to amend the rules and regulations of the Society. But the decision on the amendments shall taken by at least 2/3 rd majority of all the members of the Society.

Dissolution of the Society and adjustment of their affairs.

- (25) The annual General Meeting or extra ordinary special meeting shall have power to dissolve the Society. But decision of the dissolution shall be taken by at least 2/3 rd majority of the members of the Society.
